Coordinator Role – Salary/vehicle only (oncosts met by WBAC) \$300K
Fuel and energy audits and infrastructure - \$250k per Shire \$1.250M
Community devolved grants - \$100K per Shire over three years \$500K

The community devolved grants, managed by the WBAC on behalf of the partnership, with a strong initial focus on aged and community care facilities and low-income housing, presents multiple opportunities for positive media exposure for both Talison and the Shires across our shared communities of interest.

Each LG to contribute \$10,000.
